Council Rep petition timeline

All SPEEA Council seats will be up for new two-year terms this spring. The 2017-2019 Council Rep petition will be posted online later in February, after the SPEEA Tellers finish the Council redistricting. The Council Rep petitions are due March 29.

EIP deferral into Voluntary Investment Plan

A new feature in the SPEEA Prof and Tech contracts gives bargaining unit employees the option of putting Boeing's Employee Incentive Plan (EIP) bonus into their Voluntary Investment Plan (VIP).

As long as you make the election at least two weeks before the incentive award is scheduled to be paid out, that election will apply to your incentive award.

The incentive award program's payout is included on the same paycheck as regular pay, so the required withholding, including FICA, is taken from regular pay first and then, if necessary, from the incentive award.

Northwest Council actions – Nov. 10

At their regular meeting, the Northwest Council voted on the following motion:

- **NW16-25 PRE-SUBMITTED NEW BUSINESS: Questions for Northwest Vice President Elections** – It is moved that the following questions be submitted to the applicants for the Northwest regional vice presidential candidates and their responses be included in the voters' guide.
 1. What do you see as the primary challenges SPEEA faces and what are your solutions?

2. What do you see as the primary challenges the NW Region faces and what are your solutions?
3. What experience and skills would you bring to the Executive Board?
4. How will you represent the NW region as a regional vice president?
5. Why are you interested in the vice president position?

The motion passed. For: 70; Against: 8.

Northwest Council actions – Dec. 15

At their regular meeting, the Northwest Council: Recognized new Council Reps **Chad Keck** (E-3) and **Dan Sergent** (R-20).

Voted on the following motions:

- NW16-027 **David Baine** (A-40) referred to the 2012/2013 motion NW11-042 in presenting the motion NW16-027 and said the purpose of this motion is to clarify that \$6,000 is to carry forward annually. Motion: The NW shall budget an annual \$6,000 contribution to the Washington Fair Trade Coalition. Passed. For: 51; Against 17.
- NW16-026: Proposed 2017/2018 Budget for Northwest Region Council: It is moved that The Northwest Council approve the proposed 2017/2018 Northwest Council budget and submit the proposed budget to the SPEEA Executive Board for consideration and incorporation into the SPEEA budget. For: 46; Against: 8. The budget passed as amended.

• Budget amendments included:

- Increase Line #23 Member Self Defense Course from \$1,950 to \$3,900. Passed. For: 48; Against 16.
- Increase Line #130 Pierce CCLC, Solidarity Day – Tacoma Rainiers from \$800 to \$1,000. Passed. For: 42; Against: 19.
- Adjustments to Line #52 WSLC Convention (10) and Line #53 WSLC Legislative Conference (10) as follows:
 - Line # 52 Column C from 10 to 19, Column AJ to \$21,384, Column AL (SPEEA time) to 484 hours and Column AM (estimated SPEEA cost) to \$22,748. Line #53 Column C from 10 to 9, Colum AJ to \$4,039.50, Column AL (SPEEA time) to 106 hours and Column AM (estimated SPEEA cost) to \$4,982. For: 28; Against 24. The amendment to Lines #52 & 53 passed.

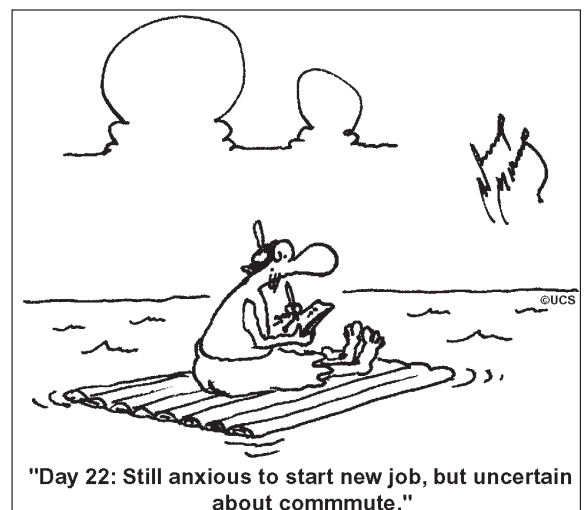

Council Rep beats the odds, despite hearing loss

EVERETT – When Tech Council Rep **Richard Hughes** reflects on his 31-year career at Boeing, he recalls the reaction from others who didn't think he would make it.

“Engineering is a communication world,” said Hughes, who can speak in a normal voice but only has 8% of his hearing. “There were some who thought I couldn't make it,” he said. “That just made me stronger.”

He suffered hearing loss from a high fever when he was three years old. He learned how to read lips so well he was able to attend public schools.

“I've been through a lot of obstacles,” Hughes said. “I learned a lot about how to communicate, about body language and lip reading and how to deal with different types of people.”

He remembers many summers spent with his mother and older brother who worked with him on his lip-reading and speaking skills. He also worked various jobs from fast food to construction and participated in sports, where he continued to build his communication skills.

He was taking computer-aided design classes

in college to become an architect when Boeing hired him to work as a drafter in flight manuals. He was 21 at the time.

In the early days at work, he would go home angry. He struggled to read lips if he was in a group setting, so he would walk away. “There was nothing I could do (about the hearing loss), so I tried to figure it out with them.”

For the past 10 years, he's worked with the same group in fleet support – aerodynamic performance at Everett's Harbour Pointe site. “I enjoy what I do – it's a great bunch of people,” he said.

His SPEEA involvement grew from his interest in contract negotiations. After asking a lot of questions, he was recruited to become an Area Rep. In 2015, on the advice of Council Reps **Jeff Aga** and **David Fritz**, he successfully ran for a Council Rep vacancy.

As a Council Rep, he likes getting information firsthand on what's happening with SPEEA. “I hate rumors,” he said. “I want to know what's actually going on. A lot of people are depending on me for that information.”
