## Raising issues at shareholders' annual board meetings

PEEA leaders recently addressed members of the board of directors at The Boeing Company and Spirit AeroSystems.

At the meetings, SPEEA leaders acknowledged successes from partnering with the respective companies but also raised concerns during the comment sections of the meetings about workplace issues, such as the impact of continued layoffs and lack of parental leave at Boeing, and outsourcing at both companies.

At the Boeing meeting in Chicago May 1, SPEEA sent

# Tax incentive accountability gets hearing

LYMPIA – Current and laid off SPEEA members testified in Olympia May 2 to support two bipartisan tax incentive accountability bills

tying Boeing's aerospace tax breaks to a mandatory minimum number of jobs.

The state House of Representatives Finance Committee held the hearing on House Bill (HB) 2145



introduced by Rep. **Noel Frame** (D-Seattle) and HB 2146 introduced by Rep. **Richard DeBolt** (R-Chehalis). Boeing cut nearly 13,000 jobs since the state legislature voted to extend the tax breaks worth a projected \$8.7 billion in 2013.

"I'm in favor of tax breaks to companies that result in good paying jobs — as the aerospace tax breaks were intended to do," said SPEEA Renton Council Rep **Mark Friesen**, who testified. "But, Boeing is taking our tax breaks and moving our state's jobs out of Washington."

Others testifying in favor of HB 2145/2146, included the Machinists, Good Jobs First, the Washington Budget & Policy Center and a number of parents and grandparents concerned about corporate tax breaks short-changing the funding for education.

At the hearing, those opposing the bills included Boeing officials, corporate lobbyists, suppliers, representatives of local business groups such as chambers of commerce and others.

Other SPEEA members who testified include Council Rep John Dimas, SPEEA VP Brent McFarlane, a recent retiree, and SPEEA staff, including Brian Metz, a former member who was laid off and is a SPEEA intern, and Stan Sorscher, labor rep.


