Workplace harassment poster

SPEEA wants to help with reporting process

To help SPEEA raise awareness about workplace harassment, this month's bulletin board features a poster addressing the issue. The poster encourages bargaining unit employees to reach out to SPEEA for help with the reporting process if they have witnessed or experienced inappropriate behavior.

A special email address, report@speea.org, noted on the poster, is carefully monitored to respect privacy.

Other related efforts:

- **Council Rep training** - At the SPEEA Leadership Conference, June 2, Council Reps had a choice of workshops, including "Workplace Harassment: Walking the Line in a #MeToo World" and a "What Me Worry" Legal System," with SPEEA legal counsel.

- **Workplace climate survey** - SPEEA Council Reps have the option of taking a confidential, informal workplace climate survey. The goal is to gain high-level insights into the frequency and severity of unacceptable behavior based on the individual's personal experience and awareness of co-workers' concerns.



Re-running Council election

The Northwest Tellers received a challenge to the results of the most recent Council Rep election in Everett District E-11.

The Tellers reviewed the matter, and with advice from legal counsel, campaign violations require re-running the election. Therefore, those election results have been set aside and a re-run of the election between the two candidates will be conducted in the coming weeks. Ballots for the re-run election are scheduled to be mailed the week of June 27.

Northwest Council actions - May 10

At their regular meeting, the Northwest Council:

- Recognized newly seated Council Rep **Brock Deady**, Auburn A-20.
- Voted on the following:
 - ♦ NW18-006 - Financial Support for Puget Sound Advocates for Retirement Action (PSARA). For: 54. Against: 7. The motion passed. The motion calls for contributing \$1,000 annually to PSARA.
 - ♦ NW18-007 - Support WA State Initiative I-1631 "Protect Washington Act." For: 26. Against: 48. The motion failed.
 - ♦ NW18-008 - Revise SPEEA NW Policy to Enable SPEEA Delegate Voting Participation in Labor Council Candidate Endorsement Deliberations. For: 36. Against: 38. The motion failed.
 - ♦ NW18-009 - Authorize SPEEA Delegate Voting Participation in 2018 Washington State Labor Council Convention. The motion was removed due to prior motion vote outcome.
 - ♦ NW18-010 - Support of IAM Workers on Strike at United Launch Alliance in Alabama, Florida and California. The motion unanimously passed.

About PSARA

The Puget Sound Advocates for Retirement Action (PSARA) leads the local effort to preserve and expand Social Security, Medicare, Medicaid and related policies.

Last year, PSARA gave more than 30 presentations on the issue of "Making Retirement Security Real for Everyone." The goal is to provide education on policy options to help people retire with economic security and dignity.

In addition to a monthly 12-page newsletter, PSARA also educates and rallies its members on issues related to workplace justice. PSARA members attend numerous solidarity actions in support of unions.

The organization started 30 years ago as a grassroots activist organization. Many of its 1,300 members are retired activists from the labor movement or other progressive causes. Annual member dues of \$20 per individual supplement the donations from other organizations, such as labor unions.
