State labor convention promotes 'Union Strong'

WENATCHEE - Hundreds of union activists, including SPEEA delegates, took part in the annual Washington State Labor Council (WSLC) convention, with the theme of 'Union Strong.'

Members traveled to Wenatchee July 17-19 to hear from speakers including AFL-CIO Secretary-Treasurer **Liz Shuler**, and delegates voted on more than 25 resolutions to help shape the WSLC's agenda and positions on key issues.

The convention delegates rallied under the theme of 'Union Strong' in light of the Supreme Court decision on the Janus vs AFSCME case, which threatens workers' voice in the workplace. The decision allows public sector workers to benefit from union representation without paying dues.

The attacks on labor, including the presidential executive orders targeting labor rights of federal workers, made a big impression on

Northwest Council Chair **Tony Hickerson**, also a SPEEA WSLC labor delegate. He attended a town hall meeting at the convention hosted by the American Federation of Government Employees (AFGE). At the meeting, he heard members talk about the impact of those attacks, including vacation day requests revoked if the member was attending a union rally.

Hickerson noted how the convention featured a recurring song, 'We Are Family.' That song

Peters, a former Area Rep, had been a Council Representative since 2016. He was serving members in the Developmental Center (Professional Unit District D-1), Seattle.

His current activities include:

- Chair of the NW Labor Delegates Committee
- Member of the NW New Hire Committee
- Member of SPEEA Diversity Committee

- Delegate to IFPTE Triennial Convention 2015, 2018

Peters' term ends March 2019 when all regional vice president seats on the Executive Board are up for election.

The election required multiple ballots of the Northwest Council to narrow the original field of seven candidates until one candidate was able to receive a simple majority of votes from the representatives.

The vacancy was created in May when **Shannon Deacon** took a voluntary layoff from The Boeing Company.

started to connect the dots for Hickerson to think of the labor movement as family. After the town hall with AFGE, he said: "I was quite upset and feeling as though I was being personally attacked. I realized it was because we're *all* being attacked. Our family, and our values, are under attack."

For SPEEA NW Regional Vice President **Daniel Peters**, also the WSLC SPEEA-Area VP, a key message was about not relying on politicians, courts or lawyers for labor justice. "We must look out for our own interests and demand justice, but we're only as strong as our members empower us to be," he said.

Highlights include:

- SPEEA President **Joel Funfar** recognized the WSLC and affiliate unions for supporting the New Middle-Market Airplane (NMA) effort to get a new Boeing plane built in the state. He also shared how the International Association of Machinists (IAM) District 751 partnered with SPEEA on a NMA study that shows Washington state is the best state to build the NMA.

- Delegates attended a workshop on the new state paid family and medical leave law. The state Employment Security Department (ESD) provided key details on how it works (starting in 2019 with benefits available starting in 2020). The law exempts union members until their collective bargaining agreements are reopened, renegotiated or expired. SPEEA is continuing to study how the new law will impact members.

- Hundreds of delegates rallied with UFCW Local 21 nurses and medical staff at Confluence Health's Central Washington Hospital to negotiate a fair contract.

WEU negotiations to resume soon

WICHITA - The SPEEA Wichita Engineering Unit (WEU) Negotiation Team is tentatively scheduled to resume contract talks with Spirit AeroSystems Aug. 20.

During the break, the SPEEA WEU team has been reviewing and analyzing options to prepare for next steps.

Last week, SPEEA hosted two workplace lunchtime meetings to answer contract and representation questions about the Wichita Engineering Unit (WEU). No contract negotiation progress could be discussed at this time.

The information provided included an overview of the SPEEA contract, the negotiation process and answered questions about union representation. New members signed up afterward.

The meeting also provided the opportunity for those interested to learn more about the process from team members who negotiate on our behalf with Spirit management.

With WEU membership at 68%, this is an all-time high for Wichita for both the WEU and Wichita Technical and Professional Unit (WTPU). "Members are signing up to support negotiations," said **BJ Moore**, SPEEA Midwest director.

At their regular meeting, the Northwest Council:

- Voted to elect an interim Northwest regional vice president. The candidates were **Shaunna Winton**, **David Wilkinson**, **Mohammed Riaz Khan**, **Lindsey J. Meiling**, **Dan Nowlin**, **Daniel Peters** and **Mehmet Ugur Koksü**. After multiple votes (the candidate with lowest number of votes removed each time), Peters was elected by majority vote.
