Hundreds rally for UI for striking workers

In a last-ditch effort to push House Bill 1893 (support for striking workers) over the finish line, hundreds of union activists took part in a rally in Olympia, Feb. 28. A number of SPEEA members and staff also took part in the rally organized by the Washington State Labor Council (WSLC), AFL-CIO. Despite passage of the bill in the House and overwhelming support from across the state, the bill came just shy of the votes needed to guarantee passage in the Senate.

SPEEA supports Machinists as union starts talks with Boeing

SEATTLE - A delegation of 10 SPEEA officers and staff were on hand to show support as Machinists Union members began talks with Boeing on a new labor agreement.

Jon Holden, the president and directing business representative of IAM District 751, took questions from reporters after the initial meeting with the Boeing negotiating team.

"This is 'Our Future, Our Fight' to secure a better life for ourselves, our families, our communities and the next generations," Holden said. "We aren't just fighting for our livelihoods at that table, we are fighting for everyone. We must never lose sight that any success at the bargaining table will be a success for current members, future union workers, engineers, other Boeing employees and the supply chain."

Along with SPEEA, representatives from Teamsters Local 174, which represents Boeing drivers, also came in a show of solidarity.

This is the first time in 16 years that the Machinists have had the opportunity to open traditional bargaining in all areas of the contract. Holden said the Machinists are focused on improving wages, health care

benefits, working conditions as well as safety and quality.

"Our members are the backbone of this company, the labor that has built The Boeing Company for generations. They deserve and have earned the right to a contract that honors their dedication, skill and years of service," said Holden. "Our goal is to negotiate an agreement our members can accept and that secures the future of aerospace. We need jobs for 50 years, not four years."

IAM represents 32,000 hourly Boeing workers in Western Washington and Portland, Ore. They work closely with the 16,500 Boeing engineers, scientists, technical workers and pilots represented by SPEEA.

Nearly 100 members stopped for coffee and donuts in Kent March 6. Council Rep Jeetendra Duwadi organized the event with his Area Reps: Matthew Negri and Austin Skondre, who were there and Michael Lee and Randy Newman who were unable to attend. He wasn't quite ready to go because he wanted to recruit more members to become active in SPEEA.

"I'm seeing a lot of newer, younger members who are interested in what the unions can bring to them. They're seeing other unions, such as teachers and the auto workers, and they're seeing unions as a good thing. They are excited to see the future of what unions can bring," he said.

"When they ask me how to get active in SPEEA, I say the best way is to become an Area Rep."

Area Rep or committee member

Council Reps rely on Area Reps to share SPEEA news and updates with members in a smaller group within their district and refer questions and issues back to their district's Council Rep.

That leads to many benefits for those who step up simply by asking their Council Rep to sign an Area Rep petition for them.

"People get to know you, and management views you as a leader," Mochow said about Area Reps. "I've never had a manager view SPEEA involvement in a hostile manner. They know they can go to you, and that's a good thing."

Not ready to become an Area Rep? Mochow would urge members to try a committee focused on issues they care about such as legislative policy, women's advocacy, diversity or new hires and young members. "Have activities for members. That's how you build bonds in between contracts."

How SPEEA activism started

Mochow started his SPEEA activism in 2011 with the kickoff of the Bargaining Unit Negotiations Support (BUNS) Committee. At the time, members were gearing up for 2012 when the Prof and Tech contracts expired.

"I was interested in the contract negotiations, so I went to the union hall for a meeting. It turned out to be the start of the committee. I was suddenly a member if I wanted to come back the next month. I kept coming."

The 2012 negotiations spilled into 2013 because members rejected Boeing's initial offers.

"I became an activist," Mochow said about his BUNS work. "I led people to go around protesting. We walked the halls leading up to executive offices with signs and chanting."

With the help of BUNS members and others, SPEEA members turned out in droves for rallies, put signs on their desks and wore red SPEEA T-shirts on Wednesdays. Turning away from apathy, "they understood how to get a better contract," he said.

As SPEEA gears up for the Prof and Tech negotiations in 2026, Mochow hopes more members become Area Reps. "They get the extra information and then get it to the people, especially in a ramp up to contract negotiations," he said. "We need to make sure people know what's going on."

SPEEA Pilots and Instructors Unit

Tech and safety pilots vote to approve contract

The members of the SPEEA Pilots and Instructors Unit (SPIU) voted to approve a new collective bargaining agreement on March 11.

The contract effective date is March 12, 2024 through March 30, 2028.

The most contentious issue in these talks was pay. The pilots' new contract includes 8.5% raises in 2024, with some of that getting paid retroactive. They also received a signing

The SPIU is made up of technical and safety pilots who perform three main functions for Boeing:

- They are the company's liaisons to the Federal Aviation Administration (FAA), National Transportation Safety Board (NTSB) and global aviation safety regulators.
- They work closely with Boeing customers to ensure the airlines have comprehensive, safe operating plans in place.
- They are on-call consultants available to help flight crews understand the nuances of safely flying Boeing aircraft.
