Unions in solidarity with locked-out Boeing union firefighters

In an unprecedented move, the Boeing Co. locked out its unionized Washington state Fire Fighters at midnight May 4.

Boeing made the move – the first work stoppage involving members of the International Association of Fire Fighters (IAFF) anywhere in the United States in more than 40 years – after the union local's negotiating team declined a Boeing demand that Fire Fighters vote for a third time on a contract offer they'd already rejected twice by overwhelming margins.

Coincidentally, the first day of the lockout, May 4, was International Fire Fighter's Day. Boeing Fire Fighters – members of IAFF Local I-66 – passed the day on the picket line, alongside other union Fire Fighters and members of SPEEA and the Machinists and Teamsters unions at Boeing.

The contract offers were rejected by union Fire Fighters because:

- Pay doesn't meet local market rates. Boeing offered raises that would leave union Fire Fighters pay 20% to 30% below the pay at local fire departments, even though the Boeing Fire Fighters have specialized training specific to aircraft production that most firefighters don't have.
- Boeing's offer would have started Fire Fighters at \$25 an hour and require

them to work 19 years before reaching top pay. The low starting pay means early-career Fire Fighters are working two jobs to make ends meet, the union says, which leads to burnout and high turnover. The union proposed a plan to move Fire Fighters to maximum pay in five years, which is more in line with local fire department contracts.

 Boeing Fire Department staffing levels are significantly below international standards.

Show support

Our union's contracts with Boeing require SPEEA members to report to work during labor disputes involving Boeing and other unions. That means all of us must continue to work during the lock-out. But you can join the picket line during non-work hours, like lunch breaks.

Local I-66's contract negotiations will set the table for the Machinists in the fall, the Teamsters in 2025 and our own SPEEA negotiations with Boeing in 2026.

Labor complaint to secure more information

SPEEA alleges retaliation in Boeing ODA case

EATTLE – Boeing managers retaliated against two SPEEA union members who had been designated as representatives of the FAA, after the union members insisted the company reevaluate prior engineering work on the 777 and 787 to account for a new FAA advisory.

That's according to our union, which on April 18 filed a National Labor Relations Board (NLRB) complaint to get access to a report Boeing filed with the FAA about the incident. The report is needed for our union to successfully appeal actions taken against one of the affected workers. The other has quit Boeing over the way he was treated. Both workers were certified for Organization Delegation Authorization (ODA) to work on behalf of the FAA.

"Boeing can tell Congress and the media all it wants about how 'retaliation is strictly prohibited," said SPEEA Director of Strategic Development **Rich Plunkett**. "But our union is fighting retaliation cases on a regular basis, and in this specific case, Boeing is trying to hide information that would shed light on what happened."
